#### **About the University Student Council**

The Dean of Students' Welfare shall be the chairman of the Students' Council The functions of the Students' Council shall be to make suggestions- to the appropriate authorities of the University in regard to the programmes of studies, students' welfare and other matters of importance in regard to the working of the University in general and such suggestion shall be made on the basis of consensus of opinion. Appropriate gender balance in the Council shall be given priority.

#### Eligibility

- 1. All the bonafide students on the rolls of the University Campus are eligible to be nominated.
- 2. Candidate should not have any academic arrears in the year of nomination
- 3. The candidate shall not have been subjected to any disciplinary action by the University authorities.

#### Format of Minutes of Meetings

The format of the Minutes of the Meeting shall comprise the following items. The minutes of the meetings should clearly reflect the agenda points.

- 1. Date, Time and Venue
- 2. List of the Members Present
- 3. Details of any Specific Invitees from Administration / Management
- 4. Agenda Items and Outcomes/Resolutions of the Discussion

#### Reporting and Dissolution

The Student Council members are liable to share the reports/minutes of the meeting/event to the Vice-Chancellor/Registrar/Dean Student Welfare. The Dissolution of the complete Student Council (or any one student/faculty member) shall be taken place at any time (on special situations leading to such act) without prior notice by the Vice-Chancelor, otherwise a notice of one week shall be given seeking explanation to show the cause/explanation for not to dissolve the council. The final decision of dissolution always rests with the Vice-Chancellor of the University.
